

Miller, William A. -- The name William A. Miller was by mistake placed on the bronze plaque in the San Jacinto memorial monument on which are inscribed the names of the Texans who participated in the Battle of San Jacinto. The name should be William A. Millen. See the sketch of Mr. Millen in this San Jacinto volume.

MILLEN, WILLIAM E. - Mr. Millen's name by mistake is shown as William E. Miller on the bronze plaque in the San Jacinto memorial monument on which are inscribed the names of the Texans who participated in the battle of San Jacinto.

Mr. Millen arrived at Velasco January 28, 1836 on the schooner Pennsylvania, having been recruited in New Orleans for the Army of Texas by Captain Amasa Turner. He was first lieutenant in Captain Turner's company at San Jacinto.

In Headright Certificate No. 83 issued to Mr. Millen February 1, 1838 for one-third of a league of land by the Board of Land Commissioners for Harrisburg County it is stated that he came to Texas in January, 1836. He was living in Harrisburg county April 12, 1838 when he sold the certificate to Elisha A. Rhodes. He was issued Bounty Certificate No. 2951 for 640 acres of land April 18, 1838 for having served in the army from February 13 to September 1, 1836. On the certificate it is stated that Mr. Millen resigned as first lieutenant September 1, On April 28, 1838 Mr. Millen sold the certificate to Elisha S. Rhodes.

Mr. Millen evidently left Texas shortly after having received his headright and bounty certificate. He did not claim the donation certificate for 640 acres of land for having participated in the battle of San Jacinto since donation certificates were non-transferable.

In Headright Certificate N^o. 83 issued to Mr. Millen February 1, 1838 for one-third of a league of land by the Board of Land Commissioners for Harrisburg County it is stated that he came to Texas in January, 1836. W. C. Swearer appeared before the Board of Land Commissioners for Harrisburg county January 18, 1838 and stated that he and Mr. Millen came to Texas in the same Boat in January, 1836. (Page 28 Harrisburg County Headright Book, General Land Office, Austin). As a matter-of-fact they arrived at Velasco January 28, 1836 on the schooner Pennsylvania, having been recruited in New Orleans for the Army of Texas by Captain Amasa Turner. Mr. Millen was first lieutenant in Captain Turner's company at San Jacinto.

Mr. Millen was living in Harrisburg county April 12, 1838 when he sold his headright certificate to Elisha A. Rhodes. He was issued Bounty Certificate No. 2951 for 640 acres of land April 18, 1838 for having served in the army from February 13 to September 1, 1836. On the Certificate it is stated that Mr. Millen resigned as first lieutenant September 1. On April 28, 1838 Mr. Millen sold the certificate to Elisha S. Rhodes. He evidently left Texas shortly after having received his headright and bounty certificate. He did not claim the donation certificate for 640 acres of land for having participated in the battle of San Jacinto since donation certificates were non-transferable.
