

BOLLINGER, EPHRIAM. Came to Texas in 1835 as is stated in the Headright Certificate issued to him February 3, 1838 by the Harrisburg County Board for one-third of a league of land. He was a member of Captain William M. Logan's Company at San Jacinto and on July 24, 1838 was issued Donation Certificate No. 407 for 640 acres of land for having participated in the battle. He was issued Bounty Certificate no. 152 for 640 acres of land on November 8, 1837 for having served in the army from March 6 to October 6, 1836. After being discharged from Captain Logan's Company June 6th, he joined Captain Benjamin J. Harper's Company.

The land received on the headright certificate issued to Mr. Bollinger was surveyed in Guadalupe County. In submitting a sketch of the Bollinger family for "Lone Star State" published in 1894 by Goodspeed Brothers, Jacob Hill, son of Mary M. (Bollinger) Hill, stated that Ephriam Bollinger was killed by Indians in 1839 but he did not state where. His death probably occurred in what is now Fayette County where his headright was surveyed.

John Bollinger and twelve children came to Texas from Pope County Arkansas, in 1833 and settled in what is now Austin County. Ephriam came in 1835. After the revolution he moved to Jefferson County. The children in order of birth were: Ephriam, Conrad, Elizabeth, Mary M., Susan, Peter, Sarah, Hiram, Caroline, Catherine, John, Jr., and Louie Bollinger.

Mary M. Bollinger, sister of Ephriam Bollinger was married to John Hill in Austin County. Their children were Jacob, John, Elizabeth and

George W. Hill.

Jacob Hill, son of John and Mary M. (Bollinger) Hill was married to Sarah A. Albright, daughter of William I. Albright. Their children were (1) Annie, (2) James H., (3) George E., (4) George B.,

BOLLINGER --

The Bollinger family came from Pope County, Arkansas to Texas in 1833. Afterwards the family moved to Austin County.

John Bollinger and wife had twelve children:

Ephriam, Killed by Indians, 1839.

Conrad, died in Austin Colony.

Elizabeth, married William I. Albright and died in Fort Bend County.

Mary M., Married John Hill of Austin County.

Susan, was alive in 1852.

Peter, alive in 1852.

Sarah, wife of H. B. Littlefield, died in Fort Bend County.

Hiram died in Austin County.

Caroline married Benjamin Allen and died in Austin County.

Gatherine, married Hillyard, County Clerk of Austin County.

John, Jr., died in Texas.

Louie died in Austin County.

Mary M. married John Hill. (She died 1855). Children (1) Jacob Hill born Austin County September 15, 1827; (2) John; (3) Elizabeth married William Pitts, Austin County; (4) George W. Died in Confederate service.

(1) Jacob Hill married Sarah A. Albright, daughter of William I. Albright. Children (1) Annie, married Arthur Gray. Mrs. Gray is dead, (2) James H., (3) Georgie E, wife of R. S. Hinsly, (4) George B., (5) William I, (6) Jacob W., and (7) John, Deceased.

Mrs. Jacob Hill died in 1889. Jacob Hill next married Lorena  
Davison of Bell County.
