BURLESON, AARON - Born in Tennessee, October 10, 1815, one of thefourteen children of James Burleson. In the headright certificate issued to him January 22, 1838 for one-third of a league of land by the Bastrop County Board it is stated that he came to Texas in 1831.

Mr. Burleson was a member of Captain Jesse Billingsley's Mina (Bastrop) Volunteers at San Jacinto and on May 25, 1838, he was issued Donation Certificate No. 63 for 640 acres of land for having participated in the battle. He was issued Bounty Certificate No. 4400 for 640 acres of land for having served in the Army from February 28 to November 1, 1836. In Comptroller's Military Service Record No. 8316 it is certified that he served in Captain Billingsley's Company from February 28 to June 1, 1836 when he was discharged at Mina and that he enlisted in Captain John J. McGehee's Company of Rangers June 1, and served until December 27, 1836.

Mr. Burleson returned to Tennessee to Marry Minerva J. Seaton.

Returning to Texas they settledat the mouth of Walnut Creek in what
is now Travis County. There Ers. Burleson died in 1855. Their children were (1) Nannie, (2) John, (3) Betty, (4) Jefferson W. (5) Maggie,
(6) Volley Burleson and two who died in infancy.

On May 15, 1856 Mr. Burleson was married to Jane Tannehill, daughter of J. C. and Jane(Richardson) Tannihill who came to Texas from Tennessee in 1829. Mr. Burleson died at Govalle, two miles from Austin, January 13, 1885, while a member of the Texas Veterans Association. Mrs. Burleson, born March 6, 1833, died April 18, 1898. Mr. and Mrs. Burleson are buried in marked graves in the Rogers Cemetery

in Travis County.

Children of Mr. Burleson by his second marriage were (7) Edward, (8) Neeley (9) Lillie, (10) Jane, Lil) Rufus, (12) William (13) Libbie, (14) Tinnie and (15) Mattie Burleson.

- (1) Nannie Burleson was married to J. W. Taylor. Their children were Hattie, who married Will Hays; Aaron, who married Mittie Brown; Quincy, who was never married; Miss Fannie Burleson; Bettie, who married Tim Redding.

Their children were Lena, who married Lee Glasscock; Jefferson, who was never married; Miss Maggie Burleson; Baylor, who was never married; Aaron who married Alma Brown; Clarence, who married Lena Smith; and John Olin Burleson, who was never married.
 - (5) Maggie Burleson who was never married.
- (6) Volley Burleson was married to Edgar V. Taylor. Their children were Robert; Stella, who married Thomas G. Banks; Marion; Edward, who married Ethel Jones and, after her death, Segar Lea; Rufus; and Milton Taylor, who married Hattie Jones.

- (7) Edward Burleson was married three times. His first wife was Beatrice Fowler. There was one child by this marriage. His second wife was Ida Taylor. To this union there was one child, Inez, who married Charles Beggett. The third wife of Mr. Burleson was Mattie Hood. Children of this marriage were: Lillie, who married a Mr. Patterson; Nola, who married Mate Fowler; Miss Mary Burleson; Rufus who married Bessie Gaines; James, who married Pauline Smith; Miss Margaret Burleson, and Aaron C. Burleson, who was never married.
 - (3) Neeley Burleson died early in life.
- (90 Lillie Burledon was a twin, the other child died at birth.

 Lillie was married to D. B. Martin; Their children were Harvey, who married Lula Grenelle; Hugh, who married Lucille Mann; Louise, who married Roy Barbish; Jennie, who married Clarence Covert; and Felix Martin.
- (10) Jane Burleson was married to R. A. Deats. Their children were Lillie, who married a Mr. Naton; Fauline, who married L. Winters and Mortimer Deats who was never married.
- (11) Rufus Burleson was married to Martha Deats. Their children were: Norma, who married J. A. Banks; Maggie, who married Champ Clark; Edward; and Raymond Burleson who married Margaret Leatherwood.
 - (12) William Burleson died in infancy.
- (13) Libbie Burleson was born a twin. The other child died at birth. Libbie was married to D. B. Matthews. They had two children who died in infancy.
